The Building Inspector stated that the primary intent with this Local Law is to speed up the process by which they would be able to get the vacant properties mowed. Previously, the process took up several weeks to get these properties cleaned up. This Local Law helps to clarify what constitutes properties that need to be addressed.

#### GRASS, WEEDS AND BRUSH

# A Purpose

In order to prevent blight and the excessive growth of weeds and grass, it is hereby declared that all lots in an approved subdivision, under which a map cover is filed with the Clerk of the County of Erie or any lot for which at least one building permit has been issued, shall be maintained in conformity with the standards set out in this chapter so as to assure that the subdivision and the community at large will not be adversely affected.

#### **B** Standards

It shall be unlawful for any person having control or ownership or any type of tenancy in any lot in an approved subdivision under which a map cover is filed with the Clerk of the County of Erie, or any lot for which at least one building permit has been issued, in the Town of Orchard Park, County of Erie and State of New York, to permit or maintain on such land, or portion thereof, any growth of weeds, grass or other rank vegetation to a height greater than 10 inches on the average, or any accumulation of dead weeds, grass or brush.

## C Removal by owner or occupant

It shall be the duty of every owner, occupant, tenant or person in control of such aforesaid land or any portion thereof in the Town of Orchard Park, County of Erie and State of New York, to cut and remove or cause to be cut or removed from the said property all weeds, grass or other rank, poisonous or noxious vegetation as often as may be necessary to comply with the provisions of 120-8.1 (B)

### D Inspection, removal by town

 Ten days after the mailing of a notice by certified mail to the last known address of the property owner, and posting of a notice on the property, the Town Code Enforcement Officer shall make an inspection, and if such inspection discloses that the owner or occupant has not complied with said notice, then the Code Enforcement Officer shall cause weeds, grass and other vegetation on such lands or portions thereof to be cut and removed. 2. If the topography of said land is such as to make it impossible or impractical to use machinery in the clearing and cutting, the Code Enforcement Officer shall first grade the land in order that the cutting and removal may be done by machinery. The actual cost of such cutting and removal, and grading, if necessary, plus a fee of 20% for inspection and administrative overhead therewith, shall be certified by the Code Enforcement Officer to the Town Receiver of Taxes and shall thereupon become a lien upon the property on which said weeds, grass and other vegetation were located, and shall be added to and become a part of the taxes next to be assessed and levied upon such lot or land and shall bear interest at the same rate as taxes and shall be collected and enforced by the same officer and in the same manner as taxes levied and assessed against such property.

### E Penalties for offenses

Any person who shall neglect to cut and remove weeds, grass or other vegetation as directed in this chapter, or who shall fail, neglect or refuse to comply with the provisions of any notices herein provided, or who shall resist or obstruct the Town Code Enforcement Officer or his employees in the cutting and removing of weeds, grass and other vegetation, or grading, if necessary, shall, upon conviction thereof, be subject to a fine of not less than \$25 nor more than \$100, and each day on which such violation continues shall constitute a separate offense.

### F When effective

This chapter shall take effect immediately after proper filing with the office of the Secretary of State.

The resolution was unanimously adopted.

## Public Hearing for a Local Law for 2012: Sex Offenders

At 7:00 PM (local time) the Supervisor called for the Public Hearing to hear all interested parties for or against the Proposed Local Law for the Year 2012: Sex Offenders

Affidavits and Publication of the Legal Notice of the Public Hearing were presented, read aloud and filed with the Town Board by the Town Clerk.

### **Comments**

**Joanne Janowski** – Ms. Janowski wished to know that once this law is passed, will it Grandfather in any offender who moved into Town prior to the law. Town Attorney Bailey stated that sadly it does not grandfather in previous offenders.

Mary Hildebrand – Ms. Hildebrand wished to know if the person who precipitated this legislation was still living at the same address. Police Chief Benz stated that the person has not changed his address with the Police Department, he does not have to notify the local police, but he does have to notify someone, such as the jurisdiction he moves into.

**Sandy Reinlander** – Ms. Reinlander wants to know why the Police did not know if the sex offender moved. Police Chief said that the offender does not have to notify the Orchard Park Police, but he does have to notify the jurisdiction he moves into. That information is then sent to Albany and then it would hit the register website.

Ray Stevens – Mr. Steven's granddaughter lives a few houses down from where the sex offender is possibly moving into. Her bus driver passed her house and then dropped her off two houses down, at the house where the sex offender is possibly moving in. Shouldn't the schools and the bus drivers be informed about the whereabouts of the predators? Police Chief Benz stated the schools are well aware of the sex offenders and are the ones who send out the notices.

# **SECTION 1**

### **Article IV - Sex Offenders**

#### **Legislative Intent**

The adoption of Megan's Law has increased public awareness of sexual offenders by requiring them to register with authorities and making such information available to the public. The Town Board of the Town of Orchard Park hereby enacts this Chapter to prevent sex offenders from residing in or living near areas where children regularly meet and congregate. The Town Board of the Town of Orchard Park believes that this legislation is necessary to further protect the best interests of all children, and to protect the health, safety, and welfare of residents in the Town of Orchard Park.

### **Residency Restrictions**

No person over the age of 18 years, who has been convicted of a violation of a sexual offense upon a child of age 16 years or under, as defined by the New York State Penal Law, which would require that individual to register as a sex offender under State and/or Federal laws, shall be permitted to reside or live within 2,000 feet of the real property of any school, park, playground, or daycare center in the Town of Orchard Park unless such residence has been assigned by a supervised release program which provides close supervision of the sex offender's daily activity, or the residency of said offender was established prior to the enactment of this Chapter.

### **Penalties for Offenses**

Failure to comply with this Chapter is considered a violation and may result in a fine of \$1,500 and/or imprisonment for 15 days.

#### **SECTION 2**

EFFECTIVE DATE: This local law shall take effect upon filing in the Office of the Secretary of State.

Councilmember Kaczor stated that the Town Attorney had done research on this Local Law and the Town Board tried to adopt a Law that pushes the envelope as much as possible. He said the other thing that residents can do is educate their children and neighbors need to look out for the children and report anything that looks suspicious to the Police.

## **BUSINESS FROM THE FLOOR**

**Jacqueline Briggs** – Ms. Briggs is president of the Senior Council, a 501C3 organization, which is dedicated to raising funds for a new senior center to accommodate the needs of our seniors, as the current center is too small. The 2010 census stated that 24.7% of our community is made up of seniors. In 2011 over 20,567 seniors used the center, and that number is growing. The Senior Center is an investment in the future as it enhances the lives of our seniors' emotional, physical and mental well-being.

**Kathryn Gorkowicz** – Ms. Gorkowicz appreciates the supporting documents for the Town Board meetings being published online. In other Town web sites, such as West Seneca and Clarence, she has found that the Planning Boards and Zoning Boards also publish supporting documentation for their meetings, have their meeting agendas posted well in advance, and also have the supporting documents available for past meetings. Ms. Gorkowicz would like Orchard Park to follow the example of these other Towns.

**David Schuster** – Mr. Schuster said that when "Quaker Splash" was first brought up that he, and other residents, wanted to know: how it was going to be brought in every night, as it is heavy; by dragging it in every night, the possibility of it being torn; how the residency requirements would be enforced; and liability – no one answered him. Now all these problems have come to fruition, and the "Quaker Splash" is up 24/7. Quaker Splash was ill conceived, poorly researched and inadequately investigated by this Board.

**Thomas Pieczynski** – Mr. Pieczynski said that he came in tonight to get some official movement on replacing the current undersized, unsafe Senior Center on Linwood. He presented a plan in February for the purchase and renovation of the Baker Road School. Mr. Pieczynski said the Town officials were elected to take care of all residents, and that includes seniors who are being ignored. Seniors are just as important as the youth and support all the local business, services and volunteer in many areas, and need the support provided by the Senior Center. The seniors would like to sit down with the Town Board to see how they can move forward with a new center.

**John Marlow** – Mr. Marlow said the Recreation Director never contacted him after he left a message on April 13<sup>th</sup>. Mr. Marlow said that "Quaker Splash" is no longer taken down at night as promised, and it was due to damage caused by the daily movement. If this is the case, it did not last 7 weeks, let alone 7 years. It looks like watchmen are being used throughout the night to prevent vandalism, will this continue for the rest of the season? Why have any regulations as all, at least 85 to 90% of the people using Green Lake are non residents, and rules are not being enforced.

Carol Jo Pope – Ms. Pope wanted to know if Green Lake is open to the public now. There is no one checking for residency, and we are not paying attention to the gift we got from Mr. Yates. She does not want Green Lake to become a destination site.

**Sharon Orendorf** – Ms. Orendorf is a teacher at the Senior Center. She stated that there is a real issue with the lack of space in the Senior Center, and that she supports a larger Senior Center. Many times there are more than one event taking place at the Senior Center, and it is hard to teach a class when that happens. She is here to support Anna Willems, the Senior Center director, and all that she does for the Seniors. Anna recently won an award from the Lions Club for her service. Ms. Orendorf and her husband go to Green Lake 3 or 4 times a week, and most cars don't have tags and there is no one checking them.

## The resolution was unanimously adopted.

Supervisor Colarusso stated that by the end of the 2013 budget process, she should have an idea where the Town is going with the Senior Center. She has been doing her homework, and talking with Anna (Senior Director) regarding Baker Road and Brush Mountain. Regarding the Planning, Zoning & Conservation Boards having their meeting back up documentation put on line, there is only one secretary to cover all three boards, their meetings and the work involved for those boards. That Department actually needs another full time person, but Supervisor Colarusso said she would talk to Rose about the possibility of posting those documents. Regarding Green Lake, Supervisor Colarusso stated that the Town really cannot close that park to anyone if the Town obtains government grants for the Park. For example, the dam at Green Lake is going to cost \$3 million to repair, and the Town may have to seek grants for that.

Town Attorney John Bailey stated that one of the prerequisites of funding from State and Federal governments is that the money be spent for the general public, and not for exclusionary purposes like running a town park only open to residents.

Councilmember Kaczor said that the "Quaker Splash" is being left up all night. The reasons - the amount of manpower it takes to move the equipment, and the potential damage to the equipment from pulling it over the terrain. The operation times for "Quaker Splash" have remained the same. As far as the permits go, the Town does not want to go to the expense of hiring anyone to police the permits at this time. As with the other concerns at Green Lake, if a problem arises, the Town Board will address it. Councilmember Kaczor stated that there are 10 to 12 thousand residents who use Green Lake for recreation and enjoy it. Councilmember Kaczor advised Ms. Briggs of the Senior Council to get the dates of their fund raisers to the Supervisor and they can be put up on the web site and in the recreational brochures. He also told Ms. Briggs to contact Ed Leak, Recreation Director, to help them with the marketing of their events.

Councilman Kaczor stated that the Town of Orchard Park has only one person who handles all the IT issues, as well as the web site. The Town is looking to hire another person for the IT Department next year, and maybe then the Town will be able to do more with the web site. He wanted to make the following announcements: Chestnut Ridge Conservancy is showing the Maltese Falcon at Chestnut Ridge on July 29<sup>th</sup> and it is free; July 25<sup>th</sup> is Caribbean Night aka the Taste Of Orchard Park; July 27<sup>th</sup> is the Ice Cream Social at the Depot; July 28<sup>th</sup> is the Lions Club Car Show in the afternoon, and in the evening is the Street Day at the Library with the Boys of Summer.

Councilmember Kaczor stated that the down turn in the economy, the drop in new homes being built, reduced sales tax revenues all affect the Town's budget. As much as the members of the Town Board would like to proceed with different projects, they have to be fiscally responsible, and wait until the Town is in better financial shape to proceed with the projects.

Councilmember Majchrzak said he was on the Planning Board and knows the secretary (Rose), if she had the time and the help, would put up all the information for the meetings on line. But at this time she is the only full time person in that office, where other Towns have a much larger staff and are able to do more. Speaking of the budget, he stated that there was a Capital Improvement project meeting in June where they discussed the many infrastructure projects, not visible to the naked eye, that need to be addressed fairly soon. Councilmember Majchrzak said the Work Session next week will not be cancelled, and will be held at the regular time.
