Supervisor Keem asked if there was anyone in the audience who would like to speak for or against the perpetual conservation easement, no one came forward.

2) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

**RESOLVED**, that the Public Hearing in the matter of the perpetual conservation easement is hereby closed at 7:09 PM.

3) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

**RESOLVED,** that the Town Board does hereby approve the Perpetual Conservation Easement for approximately 13.57 acres of vacant land to Mr. & Mrs. Able, 5685 Benning Rd, Zoned A-1. (SBL#185-4-19.1)

The resolution was unanimously adopted.

## Old Business #1 Change Order for Draudt Road Culvert Rehabilitation

4) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER SHERRY, TO WIT:

WHEREAS, the Engineering Department is requesting a Change Order to the contract with Foit Albert Associates for the Draudt Road Culvert Rehabilitation Project in the amount of \$1,500.00 or six (6) additional inspections. This would increase the total contract amount to \$5,500.00, representing an increase of 37.50%, and

WHEREAS, the Change Order is requests additional inspections necessary on Span 3 of the subject culvert. The inspections are required in response to the Red Structural Flag that was issued by the NYSDOT August 3<sup>rd</sup>, 2015. The inspections allow the span to remain open to traffic until the rehabilitation is completed, and

WHEREAS, the Engineering Department has received preliminary plans for the project and the rehabilitation work is expected to be completed in early spring of 2016 when the weather is conducive for the placement of concrete and all required permits have been obtained.

## NOW, THEREFORE, be it

**RESOLVED,** that the Town Board does hereby approve Change Order #1 to the contract with Foit Albert Associates for the Draudt Road Culvert Rehabilitation Project in the amount not to exceed \$1,500.00 per inspection, as recommended by the Town Engineer.

The resolution was unanimously adopted.

## New Business #1 Brush Mountain Park FEMA Floodplain and Floodway encroachment Analysis

5) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY SUPERVISOR KEEM, TO WIT:

WHEREAS, the Engineering Department is working to complete site work design for a multigenerational Community Activity Center at Brush Mountain Park. As part of the overall park master plan, hauling Bussendorfer Pond embankment material and topsoil for Green Lake Dam work, a new bridge to cross over the south tributary to the South Branch of Smokes Creek is recommended. The Town of Orchard Park will directly contract the floodplain modeling services for this project and add the findings to the Town's design records book, and

WHEREAS, in order to keep the project on schedule, the modeling of the creek floodplain must be completed early in the design stage. The Town Engineer solicited services from two local consultants, Wendel Architecture, Engineering, Planning Energy Services & Construction Management and Professional Civil Engineering, LLC, and

WHEREAS, the proposed scope of services and agreement with Professional Civil Engineering, LLC is satisfactory and will accomplish the goals of the project that were set forth by the Town Board. The work will involve developing a new HEC-RAS hydraulic stream model to replace the existing model, which was completed by FEMA in 1983, and

WHEREAS, the existing bridge will be modeled to determine if changes or replacement will be needed to mitigate increased flood hazards caused by the proposed bridge. With this agreement, the Engineering

Department can advise the Town Board on park improvements and sequential steps in the master plan site work for the Brush Mountain Park Community Activity Center, and

WHEREAS, funds have been allocated under Capital Project Brush Mt. Activity Center H-89.

### NOW, THEREFORE, be it

**RESOLVED,** that the Town Board does hereby authorize the Supervisor to sign an agreement with Professional Civil Engineering, LLC, 8150 Salt Road, Clarence, NY 14032 to provide professional services for the floodplain modeling at the Brush Mountain Park in an amount not to exceed \$14,640.00 excluding FEMA fees, as recommended by the Town Engineer.

The resolution was unanimously adopted.

# New Business #2 SEQR Resolution for Green Lake Dam and Dredging Project

6) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER SHERRY, TO WIT:

WHEREAS, a SEQR (Full EAF) was previously completed and signed by the Town Supervisor for the bonding portion of the project and the required grant paperwork, and

WHEREAS, Kheops, the Town's hired consultant design engineers for the Green Lake Project are in the process of obtaining the NYSDEC permits for the project's actual construction work, and this step is required for the NYSDEC approval of permits.

## NOW, THEREFORE, be it

**RESOLVED**, that the Town Board does hereby authorize the Supervisor to sign the Green Lake Dam & Dredging Project's SEQR Full Environmental Assessment Forms Parts 1, 2 & Part 3 (Determination of Significance) for the Green Lake Dam Reconstruction and Lake Dredging Project General Construction Permit as required by NYSDEC, as recommended by the Town Engineer.
