WHEREAS, the Town of Orchard Park Town Board wishes to re-organize the administration and operation of the Town of Orchard Park Parks and Grounds Department, and

WHEREAS, Highway Superintendent Fred Piasecki presently is responsible for managing the Town of Orchard Park Parks and Grounds Department, and

WHEREAS, the Orchard Park Town Board wishes to appoint Edward Leak to take Fred Piasecki's position as Director of Parks and Grounds, and

WHEREAS, the Orchard Park Town Board wishes to cancel the stipend paid to Highway Superintendent Fred Piasecki for his duties as Administrator of the Town of Orchard Park Parks and Grounds Department, and

WHEREAS, the Orchard Park Town Board wishes to make these changes effective retroactively on April 1, 2020, and

WHEREAS, the post of Director of Recreation and Parks is to be an annual appointment hereafter to be made at the Town of Orchard Park organizational meeting each year,

NOW THEREFORE BE IT RESOLVED THAT:

- 1) Highway Superintendent Fred Piasecki is hereby relieved of any and all of his duties related to the Town of Orchard Park Parks and Grounds Department, and
- 2) Town Recreation Director Edward Leak is hereby appointed the successor to Highway Superintendent Fred Piasecki in managing all of those duties related to the Town of Orchard Park Parks and Grounds Department previously managed by Highway Superintendent Fred Piasecki, and
- 3) Highway Superintendent Piasecki's stipend for his Town of Orchard Park Parks and Grounds is hereby cancelled and Town Recreation Director Edward Leak is granted an annual stipend of \$8,000 to be adjusted proportionately for the 2020 calendar with payments in full beginning in the 2021 calendar year, and
