# ORCHARD PARK HISTORICAL SOCIETY ANNUAL REPORT TO THE TOWN OF ORCHARD PARK 2021

The Orchard Park Historical Society Board typically meets 5X per year on the first Monday in Jan., Mar., May, Sept. and Nov. at 6:45 PM. The Orchard Park Historical Society membership of 120 meets on the 2nd Monday of Feb., Apr., June, Oct. and Dec. Meeting dates vary slightly due to Labor Day and Columbus Day and meeting room availability. These past 2 years, the global pandemic has forced us to suspend many of our activities, although the Officers, Board and membership continue to meet and work behind the scenes.

According to our Log Book, there were at least 334 volunteer hours spent at the Jolls House meeting, leading tours for visitors, cleaning, decorating, rotating exhibits, etc. We are caretakers of the Jolls House Museum and diligently prepare for guided tours. We were able to have an Open House over the summer. That event as well as private tours enabled us to welcome at least 58 visitors.

Our Annual Scholarship, Millie's Birthday Party, the Harry Yates Volunteer of the Year Award, and the Annual Picnic did not happen, nor did our fundraising activities and Holiday Open Houses and Annual Holiday Potluck. Without our fundraisers, which are difficult to plan in these uncertain times, we rely on membership dues and other donations.

The task of caring for the Town Museum and sharing the Jolls House and local history with our community has continued with much enthusiasm.

Our Museum Director, Lindsay Harris has coordinated work nights for volunteers, which we are now calling The Avid Archivists. They have met at least four times this fall to sort through files and donations, one of which is the **Seth Abbott family archives and artifacts**, a recent donation.

We continue to implement the recommendations of the **Documentary Heritage Preservation Services of New York assessment** that was conducted remotely in 2020. And, we are looking into ways to network with other museums and identify grant opportunities through our membership in the **Museum Association of New York**.

Our **Facebook** posts receive a lot of "likes". One picture of North Buffalo Street taken in 1945 was viewed 1500 times!

This summer we joined the Village of Orchard Park in a celebration of the Centennial. We put together a "Buggy Brigade". Our restored Amish buggy was put on display as a photo op along with Opie, a mannequin. Some of our collection of antique doll carriages and dolls were displayed, as well. Many in our community stopped by and supported our cookie sale and toured the Jolls House.

We participated in Erie County's EC200, the bicentennial celebration of Erie County, which means we are included in the **Erie County Heritage Passport** program. It has drawn people to the Jolls House for tours where they hope to spot the lantern and write down the number of our lantern, which is 33. They have their passport stamped.

Our display on the Orchard Park Village Centennial was enjoyed by all in the Historical Building at the **Erie County Fair** this summer.

Several displays have been created for the **Orchard Park Library** over the past year. One depicted the 100<sup>th</sup> Anniversary of the Village of Orchard Park.

The Society, with help from Erie County Legislator John Mills and the Village of Orchard Park, has proudly produced a brand-new color brochure, "Village of Orchard Park Centennial Walking Tour", featuring a map, photos, and over 28 points of interest.

We continue to care for the interior of the Jolls House and as always, we are thankful for the Town's upkeep of the exterior of the building. Some repairs to the porch have been made, although more repair work will be needed. Both the Society and the Town have been attempting to deal with rodent issues. The removal of overgrown trees and bushes have made the Jolls House much more visible and presentable to the community.

As mentioned, there were at least 334 volunteer hours spent at the Jolls House - this figure does not include hours spent working at home, typing letters, paying bills and more.
