Release of Escrow - Seeding All Disturbed Areas

Dear Board Members:

On October 27, 2021, the Town Board accepted dedication of the public improvements constructed in the above referenced subdivision with the stipulation that funds paid by the developer be held in escrow to install a Type C GPS monument on Sublot No. 19 for the Knoche Farms Estates Subdivision, Phase 3.

The developer has since had the above referenced work completed. The work was reviewed and approved by the Engineering Department and found to be in compliance with Town specifications.

I, therefore, recommend that you authorize the Town Clerk to release the \$15,000 held in escrow under PIP #2020-05 to install a Type C GPS monument on Sublot No. 19 for the Knoche Farms Estates Subdivision, Phase 3 to Knoche Farms, LLC, PO Box 1275, Williamsville, New York 14231-1275.
