Old Business #1 Authorize Supervisor to sign agreement with the Orchard Park School District for the Federal Aid Local Project, Orchard Park Pedestrian Walkability; Construction of Sidewalks and Crosswalks to Improve Safe Routes to Schools Project – PIN 5764.71, Contract #D040776.

2) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MOMBREA, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER LIBERTI, TO WIT:

WHEREAS, the Town of Orchard Park and the Orchard Park Central School District attorneys have completed an agreement for the Safe Routes to Schools; Pedestrian Walkability; Sidewalk & Crosswalk Construction Project; and

WHEREAS, the Town of Orchard Park Pedestrian Walkability; Construction of Sidewalks and Crosswalks to Improve Safe Routes to Schools Project is estimated at \$2,000,000. The Federal share will equal \$1,600,000 (80%) and the Local share is \$400,000 (20%). The Grant requires the Town/School to cover any overages over the 1.6 million dollar award; and

WHEREAS, the MOU covers the financial responsibility of both parties, based upon square footage of sidewalk to be installed on their respective properties. Currently the School is responsible for 50.95% (\$203,800) and the Town is responsible for 49.05% (\$196,200). These are preliminary cost figures and could change after design is complete and approved by the State; and

WHEREAS, the OPCSD and Town attorneys have gone back and forth on this agreement. The final document covers all issues and points brought up by both parties. The School District is presenting this MOU to the School Board at their meeting on April 19th for review and approval. Once approved the Superintendent of Orchard Park Schools will sign the MOU and forward it to the Town Supervisor for his signature.

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby authorize the Supervisor to execute the "Memorandum Of Understanding" between the Town of Orchard Park and the Orchard Park Central School District for the Pedestrian Walkability; Construction of Sidewalks as recommended by the Town Engineer.
