Town of Orchard Park Stadium event Vendor License is a license to sell goods, wares or merchandise upon privately owned parcels within a one mile radius from the center of the stadium. Valid only on event days for a period of four (4) hours prior to, during, and four (4) hours after the end of the stadium event. Valid only during the time period designated on the license. License shall be issued in compliance with Peddlers and Solicitors, Section 101-3, and Sections 101-5 through 101-10.*

On any stadium activity days, residents or property owners may permit vending on their premises in any zone that falls within a one- (1) mile radius drawn from the center of the stadium. This permit shall be carried by vendor on all event days and shall be presented to Police or Code Enforcement Official upon request. May be revoked for proper cause.

Violation of this chapter shall be punishable by a maximum fine of \$250.00 or by imprisonment for not more than 15 days or both. **\$15.00 fee for duplicates or copies.**
